| <b>CONTRACT HISTORY</b>   | Citizens awarded this contract through Invitation To Negotiate #16-0001 for Medical and Prescription Benefits Program to Florida Blue on June 24, 2016. Following the expiration of its original three (3) year term, on December 31, 2019, the current contract sets forth three (3) – one (1) year renewals. Citizens Purchasing Policy and Section 287.057 F.S. allow the current contract to be renewed under the terms and conditions set forth in the initial contract and any written amendments.   |
| <b>CONTRACT TERM(S)</b>   | The requested one year renewal will be effective from January 1, 2020 through December 31, 2020.   |
| <b>PURPOSE/SCOPE</b>      | This Consent Item seeks Board approval for renewing the current contract with Citizens' current Medical and Prescription Drug Administrative Services Only provider, Florida Blue, to administer all services needed for Citizens' self-funded Exclusive Provider Organization (EPO), High Deductible Health Plan (HDHP) and the Preferred Provider Organization (PPO) medical plans with a prescription benefit program to be offered to Citizens' employees, effective January 1, 2020.<br><br>Employee participation will be determined during the open enrollment period for 2020 benefit offerings. The total amount expended will be a function of employee enrollment within the offered medical and prescription drug plans. |
