
## **Recovery Cases of Interest**

## January – October 2019 Summary



2019 January through October total gross recoveries are \$2,191,142.

January through October 2019, Citizens refunded **\$143,384** to Policyholders in deductible refunds.

## **Recovery Cases of Interest**

**Other (Fraud) Loss:** These losses involve the criminal activities of a Public Adjuster who perpetrated fraudulent claims by inflating and filing false claims. He was implicated in 12-Citizens' claims and we recovered \$100,252.52 or 59 percent of the \$170,444.28 Replacement Cost Value (RCV)/indemnity payments for the 12 claims.

**Fire Loss:** This loss involves fire damage to a tenant occupied dwelling from inattentive cooking. We recovered \$34,319.60 or 76 percent of the \$45,372.50 RCV from the tenant's carrier.

**Water Loss:** This loss involves water damage to a tenant occupied dwelling, from a broken water line in the attic, which had been damaged by the cable company's technician. We recovered \$23,948.74 or 89 percent of the \$44,494.29 RCV.

**Water Loss:** This loss involves water damage inside the insured's condo unit due to a leak from the above unit. It was reported the water was off in the other unit while work in that unit was being done.

The sink drains were closed and when the water was turned back on the sink overflowed. We recovered \$11,733.50 or 100 percent of the RCV.

**Water Loss:** This loss involves water damage to an owner-occupied dwelling. The damage is reported to be the result of a faulty installation of a kitchen faucet supply line. The kitchen was remolded just over a year ago through a housing & urban improvement program. We recovered \$10,971.57 or 84 percent of the \$13,206.49 RCV.

**Water Loss:** This loss involves water damage inside the insured's condo unit due to a leak from the above unit. The leak was found to have been caused by a broken washing machine water supply line. We recovered \$25,156.33 or 99 percent of the \$25,369.14 RCV.

**Fire Loss:** This loss involves fire and smoke damage to the insured's mobile home. A vehicle, owned by the named insured and parked in the carport, started a fire, which spread to the insured's mobile home. We recovered \$7,500.00 or 60 percent of the \$12,500.00 RCV.

**Water Loss:** This loss involves water damage to a seasonal, owner unoccupied condominium. The unit above had HVAC work done and the condensation tube was drained into a trash can rather than a drain line or outside. We recovered \$15,750.00 or 100 percent of the RCV.
