PROCUREMENT METHOD	Pursuant to Section 287.057, Florida Statutes, on January 16, 2020, Citizens released Request for Proposals No 19-0025 for Financial Data Services. S & P Global Markets Intelligence submitted the only responsive proposal accordingly, less than two responsive proposals were received and pursuant to Section 287.057(5), Florida Statutes public notice was given that Citizens intended to proceed to negotiations. The Negotiation Team then met with S & P Global Market Intelligence for a demonstration. On March 3, 2020, S & P Global Markets Intelligence was determined to offer the best value for Citizens by the Negotiation Team. The Evaluation Committee and Negotiation Team were comprised of members from Citizens', Financial Services Business Analysis Team, Corporate Analytics Team Actuarial Services Team and Accounting Operations Team. Subject Matter Experts were provided by Citizens' Corporate Analytics Teams Members.
