CONTRACT ID	Court Reporting Services RFP 19-0020 RECOMMENDED VENDOR: SEE ATTACHED EXHIBIT "A"
BUDGETED ITEM	Yes. Funding for this contract is included in the 2020 Annual Operating Budget and is paid as a Loss Adjusting Expense (LAE).
CONTRACT AMOUNT	<p>The contract amount is to be determined based on Court Reporting Services provided on an as needed basis. Court Reporting Services expenses are included in Loss Adjustment Expenses.</p> <p>The recommended contracts are intended to pre-qualify vendors to be on a panel of Citizens' approved court reporting firms. Citizens does not guarantee any volume of work assignments or compensation under an awarded contract.</p> <p>The estimated cost for all contracts awarded under Request for Proposals (RFP) 19-0020, including renewals, is \$18,500,000.</p>
PURPOSE / SCOPE	<p>This Action Item seeks Board approval for Citizens to enter into contracts with nineteen (19) court reporting firms to provide Court Reporting Services in support of Citizens' Claims Litigation Department.</p> <p>Citizens is currently contracted with eight (8) court reporting firms whose contracts are set to expire on March 30, 2020.</p> <p>As such, Citizens issued RFP 19-0020 to procure vendors to continue to provide court reporting services in support of the over 13,000 open litigation claims currently handled by Citizens' Claims Litigation Department. Given the volume of pending litigation and long term need for these services, Citizens seeks to continue the efficiency and uniformity of having a contracted panel of court reporting firms through the issuance of a competitive solicitation to replace the expiring contracts and partner with new vendors capable of providing quality resources and services while utilizing a uniform and economic pricing structure based on a fixed scope of work.</p>
CONTRACT TERM(S)	The proposed contracts will have a three (3) year base term and include two optional renewal terms, the first for two (2) years and the second for one (1) year. The total term of the contracts including all renewal options is six (6) years.
PROCUREMENT METHOD	On November 12, 2019, Citizens issued RFP 19-0020 for Court Reporting Services. Vendor responses were due by December 12, 2019 and nineteen (19) proposals were timely submitted. These proposals were reviewed and scored by an Evaluation Committee who ultimately recommended to award contracts to all nineteen (19) of the vendors on January 30, 2020. A listing of the nineteen (19) vendors recommended for contracts in the Notice of Intent to Award is attached as Exhibit "A".
