BUDGETED	Yes. This Consent Item is not requesting additional funds. The requested amendment is not expected to require an increase to previously approved funds.
CONTRACT AMOUNT	The estimated contract amount is anticipated to remain at \$36,750,000 for Appraisal Services, 15-15-0022. The Board previously approved these contracts on December 9, 2015.
CONTRACT HISTORY	These contracts were approved by the Board on December 9, 2015, following the competitive procurement of RFP 15-0022 Appraisal Services.
CONTRACT TERM(S)	The contracts with Vendors for Appraisal Services have a four (4) year base term, with three (3) optional, one-year renewal terms.
	Appraisal Services, 15-15-0022: (Currently within initial term: April 9, 2016 through April 8, 2020).
PURPOSE/SCOPE	This Consent Item requests approval to amend these contracts with Appraisal Services Vendors to provide a flat fee for time spent preparing and attending civil proceedings as a fact witness in Citizens' matters. Given the frequency of the requirement for appraisers to provide testimony as fact witnesses during civil proceedings and the varying methods of compensation invoiced, Citizens has determined that there is a need to provide standardized, clearly defined billing guidelines for these services. Citizens anticipates that implementing flat fee compensation and billing guidelines will provide benefits in the form of an overall cost savings to the organization, increased operational efficiency as it relates to the processing of invoices, and improvement in the ability to forecast projected costs associated with these services.
	Under the proposed amendment, preparation and attendance at a civil proceeding as a fact witness will be compensated at a flat fee of \$525.00 for time spent preparing for testimony, and an additional flat fee of \$525.00 per day for time spent traveling to and from and testifying at the proceedings.
PROCUREMENT METHOD	Amendment to existing, previously competitively procured (RFP 15-0022) contracts with Vendors providing Appraisal Services.
