Multifunction Copier Leases/Extensions – TLH and JAX VENDOR: KONICA-MINOLTA

Topic

Citizens is requesting lease extensions involving fifteen (15) multi-function copiers in Tallahassee and Jacksonville. The current individual leases on these multi-function copiers have staggered lease expiration dates. To successfully consolidate our operational needs, extensions of up to twelve months are requested to obtain consistent expiration dates in support of this effort. This will allow coordination in making a more informed decision on the future needs of these types of multi-function copiers, on or before May 31, 2021, based on the impact of the new virtual and return to office work plan. All the leases will be aligned by December 31, 2020.

History

Each of the underlying leases for these machines was procured through State Term Contract 600-000-11-1. The pricing terms allow for these extensions (month to month following staggered expirations) within State Term Contract 600-000-11-1. Although this State Term Contract has recently expired, Florida's Department of Management Services has confirmed that our agreements survive, and we are permitted to extend these terms accordingly with Konica Minolta for the rates established within the State Term Contract.

| CONTRACT TERM(S) | The proposed lease extensions will be for month to month terms, for a maximum of (12) months for alignment of all these leases by December 31, 2020. The decision on future needs is anticipated on or before May 31, 2021. |
| PURPOSE/SCOPE | Purpose: This Consent Item summary seeks Board approval for lease extensions for 15 multi-function copiers located in Jacksonville (9) and Tallahassee (6). Based on the current work from home status, and as a result of COVID-19, it is recommended to extend these leases, through June 30, 2021, versus entering new three-year contracts. Each of these multi-function copiers have staggered lease expiration dates and to successfully consolidate these dates an extension of up to twelve months, as needed, will support this effort. This will allow time to make a more informed decision based on the impact the new virtual and return to office work plan has on office operations. Scope: The new lease agreements will be made pursuant to State Term Contract 600-000-11-1 procured by the State of Florida. This extension will allow Citizens to align the current machines to the same expiration date. |
| PROCUREMENT METHOD | These leasing services will be procured utilizing the Florida State Term Contract No. 600-000-11-1 which meets the requirements of Citizens' Purchasing Policy. |
| RECOMMENDATION | It is recommended that Citizens' Board: a) Approve these lease extensions not to exceed \$36,000 with Konica-Minolta under State Term Contract 600-000-11-1 for Jacksonville and Tallahassee multi-function copiers to allow alignment of all leases by December 31, 2020, as described in this Consent Item; and b) Authorize staff to take any appropriate or necessary action consistent with this Consent Item. |
