## **Executive Summary**

## Water Mitigation and Mold Remediation Estimate Review Services

This Action Item seeks approval to contract with the vendors as listed on the Notice of Intent to Award, published on November 17, 2020, in response to RFP 20-0020 for Water Mitigation and Mold Remediation Estimate Review Services. They are Lynx Services, LLC (Primary Award) and The Fast Team, LLC (Contingent).

## **History**

Citizens' Water Mitigation and Mold Remediation Estimate Review Program currently uses Lynx Services to conduct independent objective reviews of all water mitigation invoices submitted by any mitigation company. This contract began on August 8, 2016 and will expire on August 7, 2021. Over 18,000 assignments were completed during the contract term with a total contract spend of approximately \$2,773,730. Although a significant expense, this has historically resulted far greater claims expense reductions for these types of invoices, which savings, by multiple factors, more than offset the total contract spend.

During the past contract term, the typical audited invoice process generates substantial reductions from the original invoiced amounts. The total savings achieved from all original invoice reductions often exceeds \$1,000,000 per month. This has been a very successful program whose results are anticipated to continue.

As a result of contract expiration, Citizens' Claims department issued RFP 20-0020 on August 25, 2020 to secure a vendor who will continue to perform independent, objective, and expert reviews of all water mitigation and mold remediation invoices submitted by any mitigation company. The vendor will be required to determine if the invoices are reasonable and in adherence with industry standards and guidelines. An objective review of invoiced mold damages will also be reviewed and assessed.

The vendor will assess contractor invoices for restoration work performed on residential, commercial and specialty property losses due to water and mold damage. The vendor will be responsible for identifying overcharges and, when requested, will assist with recovery of overcharges. This can include working with attorneys to settle the matter or provide testimony as an expert witness in legal proceedings. The review process is required to follow Xactimate, IICRC (The Clean Trust), and industry recommendations, in conjunction with scientific drying methodologies.

Six (6) vendors responded to RFP 20-0020 for Water Mitigation and Mold Remediation Estimate Review Services. Each vendor was thoroughly evaluated by the designated Evaluation Team. Two (2) vendors (referenced above) were recommended for award on November 17, 2020, having significantly higher scores from the Evaluation Team. Lynx Services, LLC received the highest overall score. In addition, Lynx Services, LLC received the highest score for its most favorable pricing, immediately followed by The Fast Team, LLC. Also, significantly, Lynx's pricing is consistent with current pricing and will remain stable for the entire initial three-year term of the contract. If the renewal option is exercised for the two-year renewal options, the increase is 5 percent. Citizens' staff remains confident that these vendors can meet Citizens' needs for the next (5) years.

Procurement Method	The Request for Proposal for Water Mitigation and Mold Remediation Services, RFP 20-0020, was issued on August 25, 2020. This solicitation resulted in six (6) vendors submitting proposals which were each evaluated for potential award. The Notice of Intent to Award was published on November 17, 2020, with an intent to award this contract to Lynx Services, LLC (Primary), with The FAST Team LLC awarded as a contingent vendor, should the Primary prove unable to perform.
Contract Amount	The estimated contract amount is \$1,678,500 for the recommended (3) year base term of the contract and \$1,347,680 for the two (1) year renewal option, for a total of \$3,026,180.
Contract Terms	The contract term is a (3) year base term with (2) optional (1) year renewals.
