Vision Insurance Coverage

Summary

This Vision Insurance Coverage Action Item will be presented at the September 22, 2021, Citizens Board of Governors Meeting.

Recommended Vendor: Davis Vision

History

Davis Vision is the incumbent provider under a one-year current contract with Citizens for Vision Insurance Coverage, which concludes on December 31, 2021. The new contract with Davis Vision is the recommendation for Citizens by its Benefits Consultant, Mercer Health & Benefits, LLC. In addition to its initial one-year term, this contract also includes three (3) one-year renewal terms.

Mercer conducted a survey with several national carriers for these types of coverages. This showed increases between 3%-5% for policies starting January 1, 2022. The new four-year contract includes a 3% increase to the rates for the next three years. In year four, rates will remain flat with zero increase. The contract period is effective January 1, 2022 through December 31, 2025.

Estimated total cost of Vision Insurance Coverage through Davis Vision for the contract period of January 1, 2022 through December 31, 2022, is approximately \$120,060. The estimated total cost for the three (3) one-year renewals is estimated at approximately \$378,405, depending upon future enrollment.

This fully insured voluntary insurance product is 100 percent employee paid.

The actual total amount expended will be a function of employee enrollment in the Davis Vision plan during enrollment periods.

Recommendation

It is recommended that the Board of Governors:

- a) Approve the initial term of one-year with Davis Vision from January 1, 2022, through December 31, 2022, together with three (3) one-year renewals for the estimated total contract amount of \$498,465, as described in this Action Item; and
- b) Authorize staff to take any appropriate or necessary action consistent with this Action Item.
