Executive Summary

Board of Governors Meeting, September 22, 2021

Dental Insurance Coverage

Topic

This Dental Insurance Coverage Action Item will be presented at the September 22, 2021, Citizens Board of Governors Meeting.

Recommended Vendor: MetLife

History

MetLife is the incumbent provider under a one-year current contract with Citizens for Dental Insurance Coverage concludes on December 31, 2021. The new contract with MetLife is the recommendation for Citizens by its Benefits Consultant, Mercer Health & Benefits, LLC.

Mercer conducted a survey with several national carriers for these types of coverages. This showed increases between 3%-5% for policies starting January 1, 2022. Since MetLife has agreed to hold their rates for 2022, Mercer recommends that the MetLife coverages are the best option at this time for Citizens.

Estimated total cost of Dental Insurance Coverage through MetLife for the contract period of January 1, 2022 through December 31, 2022, is approximately \$977,000.

Citizens and its Employees both share in the contribution level cost at 85/15 percent:

- Citizens estimated cost \$828,000
- Employees estimated cost \$149,000

The actual total amount expended will be a function of employee enrollment in the MetLife Dental plan.

Recommendation

It is recommended that the Board of Governors:

- a) Approve the one-year contract with MetLife from January 1, 2022, through December 31, 2022, for the coverage listed above at a total estimated cost of \$977,000 as described in this Action Item; and
- b) Authorize staff to take any appropriate or necessary action consistent with this Action Item.
