Litigation Avoidance Strategies

- Product Language Changes Effective 8-1-19
 - Non-Weather Water \$10,000 sublimit
 - \$3,000 vendor cap included within the \$10,000
- Managed Repair re-launch effective 8-1-19
 - Free water mitigation services
 - Permanent repairs with credentialed contractors that provide a 3 year workmanship warranty
- HB 7065 AOB Reform effective 7-1-19
 - Establishes compliance standards
 - Requires Notice of Intent prior to filing suit
 - Sharing of Plaintiff Attorney Fees based on outcome



Litigation Avoidance Strategies

- SB 76 Notice of Intent to file suit effective 7-1-21
 - Requires new suits to provide insurer with NOI prior to filing suit
 - Provides insurer the ability to negotiate with Plaintiff Attorney, to conduct reinspections or to demand Appraisal to prevent litigation
- Utilization of Appraisal strategies to resolve disputes without the need for litigation
- Quality Assurance program designed specifically to evaluate effectiveness of litigation avoidance strategies
- Training for Non-Litigation Claims teams on litigation avoidance
