



**AMENDMENT – ASSIGNMENT AND ASSUMPTION No. 1 to the  
BUSINESS PROCESS OUTSOURCING (BPO) – CALL CENTER SERVICES –

WHEREAS, Citizens and Assignor desire to amend the Agreement to assign the same to Assignee.



To the extent that Assignor still exists, it shall remain secondarily responsible and liable for the performance of the terms and conditions of the Agreement should Assignee fail to satisfactorily perform them.
3. Assignee is now a party to the Agreement assumes the rights, obligations, and liabilities of Assignor under the Agreement.
4. Assignee acknowledges and agrees that it has in its possession all Agreement documents and fully understands its rights, obligations, and liabilities thereunder.
