### Special Investigative Services

### **Topic**

This Action Item seeks approval to contract with eight (8) vendors to provide Special Investigative Services related to potential insurance fraud, as identified in Attachment A. Approval is requested for a three (3) year base term with one (1) two (2) year optional renewal term, not to exceed \$1,600,000 across the base and renewal terms.

### **History**

Citizens' Special Investigation Unit (SIU) is a dedicated unit that conducts investigations pertaining to fraudulent or false insurance claims and other fraud-related actions against Citizens throughout the insurance cycle. The unit is comprised of the following four (4) teams where investigations are triaged and assigned accordingly:

- Major Case Unit
- Field Investigations
- Outsourcing/Investigative Research
- Agency/Underwriting Investigative Team

The SIU utilizes approved Special Investigative Services vendors to conduct investigations effectively and efficiently to maximize capacity and allow for scalability of investigative services in response to a CAT event. SIU uses these contracted vendors to maintain the efficiency and effectiveness needed to detect, deter, and prevent insurance fraud from being perpetrated against Citizens. SIU will also be expanding to provide agency and underwriting assignments to these outside investigators.

Approval is requested to contract with five (5) vendors for primary contracts, and three (3) vendors for contingent contracts, as identified in Attachment A. The contingent contracts could be activated by Citizens as needed within thirty (30) days' notice. The contingent contracts are intended to help ensure that Citizens has the necessary resources in the event of vendor attrition and/or increased volumes.

Citizens procured the contracts through Request for Proposals 23-0003 for Special Investigative Services, issued on March 21, 2023. Eleven (11) of the thirteen (13) responding vendors met Citizens' mandatory requirements. The Evaluation Committee recommended award of primary contracts to the top five (5) ranked vendors and contingent contracts to the next three (3) ranked vendors on June 1, 2023. Attached is a copy of the Notice of Intent to Award listing the selected Vendors.

The proposed contracts include a three (3) year base term with one (1), two (2) year renewal term, which may be exercised at Citizens' sole discretion. Approval is requested for an amount not to exceed \$1,600,000 including renewals.

When the current contracts were awarded in 2018, Citizens' policy count was approximately 443,000. The approved spend for the 2018 contracts is \$1,000,000. There is \$199,456 approved spend remaining

as of April 2023, and the contracts expire December 5, 2023. Citizens' current policy count gives confidence that \$1,600,000 for the proposed new contracts will be sufficient. The increase in policies in force has contributed to the need for more fraud investigation resources.

Since the beginning of the current Special Investigative Services contract, 894 claims were handled by SIU vendors from the beginning of the contracts through April 2023 with an average vendor cost of \$1,050.72. Out of all claims handled by SIU vendors, 28% of these claims were catastrophe related claims.

With an average policy count of 674,885 from January 2019 to January 2023, we have received roughly 106,837 non-catastrophe related claims from January 2019 – December 2022 and generated 0.6% of SIU referrals that went through this program at \$1,053.82 average cost. With steady increases in PIF counts, if we have 1,700,000 policies and claims reported at 15.8%, we can forecast 335,750 non-catastrophe related claims over the next five years.

After discussions with SIU leadership, we are anticipating 1,500 claim investigations for the new contract term. Our outsourcing team consistently handles 60 per month or 620 per year; 40% of these go to vendors or 248 per year (20 per month) at an average of \$24,000 per month or \$288,000 per year. We are estimating \$1.5 Million with another \$100,000 to include Agency and Underwriting efforts, thus bringing the total to \$1.6 Million.
