## Contingent Staffing Services – Additional Spend Request

### Topic

Citizens staff is requesting approval to increase the approximately \$1.5M annual spend under Citizens' current Contingent Staffing Services Action Item 07Aa\_12.9.15. The Contingent Staffing Services contracts provide contingent staffing resources, on an hourly basis, needed to help support its overall scalable staffing model. This companywide support covers regular business operations including the area of Catastrophic (CAT) events. The request is to increase the contract amount from approximately \$1.5M annual spend to \$1,812,281.92 for 2023, and \$2,737,740 for each of the years 2024 and 2025 for a total increase of \$2,787,761.92 through the end of the contract term, December 20, 2025.

Independent adjusters are covered under separate contracts, not within this request.

#### **History**

Citizens entered into Contract No. 15-0019 Contingent Staffing Services on June 15, 2015, pursuant to Request for Proposal 15-0019 Contingent Staffing Services with multiple vendors. The contracts include a five (5) year base term followed by five (5) optional one (1) year renewal periods. The total contract amount for the ten-year term was earlier approved at approximately \$15 million. The contracts will expire December 20, 2025. In addition to supporting Citizens scalable staffing model, the resulting Contingent Staffing Services Agreement allows Citizens to add flexible, short, and long-term staffing support required to meet specific business needs for companywide assignments for normal business and Catastrophic (CAT) events.

Spend is aligned with the annual budget in each business unit on an 'as used' basis and only incurred in the event contingent hours are worked. There is no minimum payment or promise of revenue. The current Contingent Staffing Services vendors are listed on Exhibit A.

Citizens Human Resources has facilitated an increase in Contingent staffing usage, in part to support Underwriting initiatives and anticipates the spend for Agreement No. 15-0019 will exceed the earlier approved amount of \$1.5M annually, prior to the end of the contract term.

This Consent Item seeks Board approval for an additional \$2,787,761.92 for a total approved spend of \$7,287,761.92 over the course of the remaining contract terms, through December 20, 2025.
