EXECUTIVE SUMMARY

- Citizens' total portfolio market value for Oct 2023 was \$9.78 billion (prior month: \$9.90 billion) with an average duration of 2.73 years (prior month: 2.80 years) and average credit ratings of AA-/Aa3/AA-.
 - 97% of the total portfolio is taxable, with a market value of \$9.50 billion.
 - 3% of the total portfolio is tax-exempt, with a market value of \$0.28 billion.
 - 84%, or \$8.25 billion of the total portfolio is managed by 10 external investment managers, with an average duration of 3.21 years and 16% or \$1.53 billion is internally managed.
- 2023 Oct year-to-date (YTD) income return of Citizens' total portfolio is 2.41%. YTD average assets are \$9.3 billion. Oct YTD total return of the total portfolio is 1.54%.
- 36% of the portfolio matures within six months, 42% within one year, and 18% in one to three years.
- The 2018-2022 total portfolio's annualized net income return is summarized below:
















Tax-Exempt Portfolio Credit Quality Distribution (\$ in Millions)










PORTFOLIO MATURITY DISTRIBUTION
