CONTRACT HISTORY	<p>The Board, on January 29, 2014, approved the estimated fees of \$33,250,000 for the life of the contracts, including renewal terms based on a \$13.5 billion managed portfolio. Contracts were executed April 1, 2014 with 16 Investment Management Services Vendors. As stated in the original Action Item for services, fees will be and are calculated on the total market value of Citizens' assets.</p>						
CONTRACT TERM(S)	<p>Contracts were approved by the Board on January 29, 2014 for a three-year base term with optional two, one-year renewals.</p>

CONSENT ITEM

PROCUREMENT METHOD	On September 14, 2013, Citizens issued Invitation to Negotiate (“ITN”) No. 13-0002 for Investment Management Services with responses due by October 2, 2013. Citizens received 36 proposals. The proposals were evaluated by a four member evaluation team. Sixteen firms were recommended to the January 14, 2014 Board for approval.
RECOMMENDATION	Citizens’ staff recommends that Citizens Board of Governors: a) Approve the recommended one-year renewal for the named Investment Management Services firms; and b) Authorize staff to take any appropriate or necessary actions consistent with this Consent Item.
