Financial Data Services

Topic

This Action Item requests approval to contract with S&P Global for Financial Data Services. Approval is requested for a five (5) year term with no renewal options for an amount not to exceed \$225,115. The services assist Citizens with researching and analyzing the Florida property insurance market and supports Citizens' product, rate, and rule filings with the Florida Office of Insurance Regulation (FL OIR).

History

S&P Global has provided Financial Data Services to Citizens since May 9, 2015. The proposed contract will replace Citizens' current five (5) year contract that expires May 8, 2025. The price for this new five (5) year term reflects a 5% increase for each year over the five (5) year contract. A Citizens evaluation committee selected S&P Global for award through Request for Proposals No. 24-0014.

The services provide data, analysis, and research tools for a broad range of information on the Florida property insurance market. Staff use the tool to research market activity and trends including carrier financial metrics, market share data, and filings with the FL OIR. The services provide customized reports and news alerts in addition to standardized reports on various topics. Additionally, it provides a valuable tool for assessing the market in support of Citizens' product, rate, and rule filings with the FL OIR.

Recommendation

Staff requests that the Finance and Investment Committee review, and if approved at its March 12, 2025 meeting, recommend the Board of Governors:

- a) Approve the Financial Data Services contract with S&P Global for a five (5) year term at an amount not to exceed \$225,115 as set forth in this Action Item; and
- b) Authorize staff to take any appropriate or necessary action consistent with this Action Item.

Financial Data Services

Procurement Method	On November 13, 2024, Citizens issued Request for Proposals: No. 24-0014 for Financial Data Services. Two (2) vendors submitted replies, Bloomberg Finance LLP, and S&P Global. The proposals were reviewed and scored by a Citizens Evaluation Committee who recommended the award to S&P Global on February 11, 2025.
Contract Amount	Not to exceed \$225,115 for the five (5) year term of the contract. The contract does not include any renewals.
Contract Terms	Five (5) year term with no renewal options
