The Florida Market Assistance Plan is a service organization created to assist applicants who are unable to acquire property and casualty insurance from authorized insurers. FMAP is funded by a \$450 annual assessment of residential property insurers included in the 2025 budget is 588 residential property insurers with an annual assessment of \$450 totaling \$264,600 with expenses of \$234,414. There's the Change in Unrestricted net assets of \$30,186 and the net assets at the end of the year of \$933,411. Are there any questions?
