Court Reporting Services

Topic

This Consent Item seeks Board approval for Citizens to enter into new contracts with twenty-one (21) court reporting firms to continue Court Reporting Services in support of Citizens' Claims Litigation Department.

History

The Court Reporting Services Program is intended to provide Citizens with a network of experienced and credentialed vendors capable of providing court reporting, transcription and video services in support of Citizens' Litigated Claims Department. Citizens currently has over 8,500 open litigation claims assigned to the Claims Litigation Department. As part of the coordinated defense of its litigated claims, Citizens' contracted outside counsel routinely engage these court reporters throughout the state to provide required court reporting and transcription services. Through the Court Reporting Services contracts, these vendors provide quality resources and services while utilizing a uniform and economical pricing structure based on a fixed scope of work.

In addition to continuing services currently under contract and set to expire, Citizens seeks to add new technology and services related to the modern delivery of court reporting services. These additional services seek to: (1) ensure our contracted outside law firms have access to those services needed for effective representation and trial performance, (2) ensure Citizens' vendors are providing the most current and efficient services and delivery/performance methods available relative to various evolving market conditions and (3) provide remote video conferencing related services to allow for more cost and time efficient performance of services by contracted outside counsel and other parties involved in litigation on behalf of Citizens.

On June 2, 2025, Citizens issued Request for Proposals (RFP) 25-0007 for Court Reporting Services. Twenty-three (23) proposals were reviewed and scored by an Evaluation Committee who ultimately recommended contracts to twenty-one (21) of the vendors on July 29, 2025. A listing of the twenty-one (21) vendors recommended for contracts in the Notice of Intent to Award is attached as Exhibit "A".

The proposed contracts will have a base term of three (3) years starting from the date of contract execution. Each contract will also have one optional three (3) year renewal term.

The pricing under these contracts includes an upward adjustment to reflect market-wide price increases for these services since the procurement of the existing agreements back in 2019. This pricing adjustment ensures Citizens has access to an appropriate number and quality of court reporting providers. Pricing for the contracts procured under RFP No. 25-0007, as was the case with the existing contracts procured under RFP No. 19-0020, were determined through a multi-phased analysis that included (1) comparing the pricing for similar services available under State Term Contract 82111603-24-STC, (2) adjustments to reflect Citizens' volume of work and the primary location of the performance of these services, and (3) an internal market analysis. Pricing caps for services were set approximately 5% below the rates for

comparable services under the State Term Contract, with vendors allowed to offer up to a 30% discount. Eighteen (18) of the awarded vendors submitted bids with discounted rates.

The table below shows the percentage price increase for the *maximum* price allowed for each service under the contracts awarded through RFP No. 25-0007. Eighteen (18) of the twenty-one (21) awarded vendors submitted discounted pricing bids. Specifically, we had four (4) vendors offer 5% discount, seven (7) vendors offer 10% discount, five (5) vendors offer 15% discount and two (2) vendors offer 30% discount from the prices below.

Citizens estimates the costs for these services to be around \$8 million per year, for each year of the initial and renewal terms. Estimated costs for these services are based on anticipated court reporter usage and subject to pending litigation volume. Although these services have increased in price, litigation volume is currently experiencing a decrease, due to legislative changes, reduction in PIF and the success of the DOAH initiative. At the same time, litigation volume trends can reverse over the course of this agreement due to Catastrophe impacts, changes to PIF or other factors that may result in increased litigation volume.

Recommendation

Court Reporting Services

Contract Terms	The contracts will have a three (3) year base term and include one optional three (3) year renewal term. The total term of the contracts including all renewal options is six (6) years. The contracts qualify vendors within Citizens' panel of court reporting vendors, with pre-negotiated favorable pricing, but do not guarantee any volume of assignments or compensation.
