### Mobile Home Demolition Services

#### **Topic**

This Consent Item seeks approval to continue utilizing the Mobile Home Demolition Services panel contracts throughout the renewal periods up to July 24, 2030. The Board earlier approved \$1,300,000 for the life of these contracts in July 2024. However, Citizens is seeking additional authority due to the effects of three (3) hurricanes that impacted Florida last year, Debby, Helene, and Milton. The revised estimated spend for the entirety of the contract is now approximately \$6.6 million.

#### **History**

Section 319.30, Florida Statutes, requires Citizens to obtain the title to any mobile/manufactured home that has been determined by a Claims' Adjuster to be a total loss. As a result, it is Citizens' responsibility to ensure proper demolition and removal of all mobile/manufactured homes that have been determined to be a total loss.

Currently each contracted primary vendor on the panel provides Citizens with experienced personnel and equipment to safely demolish, remove, and properly dispose of all mobile home debris and remnants from an insured property, regardless of the severity, in non-catastrophic and catastrophic situations. Each vendor provides services to Citizens and Citizens' policyholders throughout the entire State of Florida.

The services include:

- Demolition The systematic, appropriate, and safe destruction of a mobile/manufactured home structure
- Removal The safe and lawful removal of all mobile/manufactured home debris and remnants from a property.
- Disposal Ensure the safe, proper, and legal disposal of all mobile home debris and remnants in accordance with state and local laws, regulations and/or restrictions.

On July 25, 2024, with Board approval, Citizens entered contracts with five (5) primary and five (5) contingent vendors to provide timely delivery of Mobile Home Demolition Services for a three (3) year base term with one (1) three (3) year optional renewal term, for an amount not to exceed \$1,300,000.00 for the life of the contracts.

As of July 22, 2025, a total of \$991,202.29 has been spent leaving a balance of \$308,797.71. Of this total, \$895,190.55 was for Catastrophe (Cat) claims with \$96,011.74 expended for Non-Cat claims. The estimated cost for the remaining five years of this contract for Non-CAT is now \$842,413.

For CAT-related categories, the five-year estimated spend is divided by impact level. Since 2019, Citizens was impacted by 3 major events: (Hurricanes Ian, Milton and Michael) which averaged \$1,004,111 per event. Additionally, Citizens was impacted by 9 minor Cat events (Several lesser Hurricanes and pocket storms) which averaged \$61,514.39 per event. The chart below demonstrates the breakdown of Mobile Home Cat and Non-Cat claims since 2019.

CAT events with minor impacts are expected to cost \$327,049, while CATs with major impacts are projected at \$5,338,477. Combined, the total estimated spend for CAT (both minor and major impact) over the remaining five years of this contract amounts to \$5,665,526.

Altogether, the total spend request for the remaining five years of this contract, incorporating both Cat and Non-Cat forecasts, and the projected PIF reduction of 8.6%, is now approximately \$6,600,000.

Citizens is seeking authority to continue to utilize these contracts as needed through July 24, 2030. The total amount spent is contingent on utilization, which may vary depending on several factors, including policy count and catastrophes.

#### Recommendation
