Purpose / Scope	This Action Item requests Citizens Board of Governors approval to authorize staff to enter into a contract with the vendor identified above to provide Managed Cloud Support services for an initial six (6) month contract period, beginning July 1, 2018. Implementation of Centerpoint, which is Citizens' Oracle Fusion integrated enterprise resource planning system, is expected to be completed in August 2018. Maintenance of the system for the already implemented modules are more than Citizens anticipated. Citizens' current production support capacity is consumed by the demands of the ongoing implementation, post production support, and mandatory Oracle software maintenance releases and upgrades. To meet those demands, which may vary, Citizens believes it prudent to outsource a portion of these services.	
	Managed Cloud Support services provided by Oracle ACS includes the resolution of assigned production support work, review and assessment of impacts from monthly/quarterly patches required by Oracle, the facilitation of service requests from creation to resolution to address Oracle software bugs identified by Citizens, and other maintenance and support services that might be needed to support Centerpoint.	
CONTRACT TERM(S)	July 1, 2018 thru December 31, 2018	
PROCUREMENT METHOD	Citizens Purchasing Policy No. 501 authorizes the use of any State Term Contract or Alternate Contract Source approved for use by the Florida Department of Management Services (DMS).	
	On February 1, 2017, the DMS approved the use of the Oracle Products, Services, and Solutions contract via DLT Solutions, LLC as an Alternate Contract Source as authorized by subsection 287.042(16), Florida Statutes.
