BUDGETED ITEM	Yes.
CONTRACT AMOUNT	The estimated cost of the proposed contracts is not to exceed \$38,000,000 for base term with an additional \$38,000,000 if all renewals are exercised. Total estimated cost of the proposed contracts, including base term and renewals, is not to exceed \$76,000,000. The cost of this program has been accounted for in the approved \$343,900,000 for the Independent Adjusting Services-Non-Litigated/Catastrophe RFP 17-0006 and no additional spending authority is requested in this Action Item.
PURPOSE / SCOPE	This Action Item seeks approval for Citizens to enter into contracts with multiple qualified vendors that are able to provide Field Inspection Services for a Catastrophe Response in order to memorialize the condition of the property involved in the loss through documentation (documenting damages, notes, diagramming, and attaching photos). Field Inspectors will be responsible for uploading and attaching documents via a software tool that integrates with Citizens Estimating System – Xactimate. All Field Inspectors providing Services must be authorized as emergency adjusters by the Florida Department of Financial Services (DFS) in accordance with 69B-220.001, F.A.C., or authorized (licensed) by DFS to adjust claims in Florida. These contracts will only be activated in response to a declared catastrophe. Citizens intends to contract with enough vendors to secure the necessary field inspectors to provide Field Inspection Services until the necessary amount of resources are verified as having met Citizens' requirements.
Contract Term(s)	The proposed contracts will have a five (5) year base term with optional five (5), one (1) year renewal terms (the "Renewal Term"), which may be exercised upon mutual agreement of the parties.
PROCUREMENT METHOD	On April 13, 2018, Citizens issued Request for Proposals (RFP) 18-0023 for Field Inspection Services. Responses were received and scored by an Evaluation Committee. The Evaluation Committee recommended primary award to multiple Field Inspection Services vendors on June 12, 2018. A listing of the firms recommended for award in the Notice of Intent to Award is attached as Attachment "A".
