

Terrain Issue for Wind-Only Clearinghouse Quotes



Some agents are not receiving a valid Citizens quote in the Property Insurance Clearinghouse for the following policy types:

- *Homeowners 2 – Wind-Only Form (HW-2)*
- *Homeowners 6 – Unit-Owners Wind-Only Form (HW-6)*

To receive a valid Citizens quote for HW-2 and HW-6 risks, agents should select **C** for the *Terrain* field in the clearinghouse quote.

If the *Terrain* field shows a different value, the agent must change the *Terrain* field to **C** on the *Step 1: Provide information* screen:
